**Description:** Products covered: ICS: 97.040.20 (Cooking ranges, working tables, ovens and similar appliances).

This addendum concerns the notification of the Ministerial Decree No.58/2026 (2 pages, in Arabic) that gives the producers and importers a twelve -month transitional period to abide by the Egyptian Standard ES 164-1-4 for "Domestic gas cooking appliances — Safety Part 1-4: Particular requirements for ovens and compartment grills"(45 pages, in English).

It should be noted that the Ministerial Decree No. 423/2005 (25 pages, in Arabic) which was formerly notified in G/TBT/N/EGY/3 dated 14 December 2005 and the Ministerial Decree No. 1002/2017 (3 pages, in Arabic) which was formerly notified in G/TBT/N/EGY/3/Add.8 dated 10 January 2018, mandated among others the earlier versions of this Standard and the draft of this standard was formerly notified in G/TBT/N/EGY/3/Add.100 dated 7 January 2026.

Worth mentioning is that this standard adopts the technical content of ISO 21364-22:2025.
