Description of content:</b> This draft of Egyptian standard specifies requirements for materials intended for use in the construction of the hull, superstructure and appendages, in particular:</p> <ul style="list-style-type: none"><li>• Weldable normal and higher strength hot-rolled steel plates, wide flats, sections and bars;</li><li>• Austenitic stainless steels, fabricated in the form of plates or profiles;</li><li>• Wrought aluminium alloys fabricated as plates, sections and extruded profiles;</li><li>• Wood in the form of solid timber, plywood or veneer;</li><li>• Other suitable materials.</li></ul> <p>It applies to small craft with a hull length (LH) according to ISO 8666 of up to 24 m. Worth mentioning is that this standard adopts the technical content of ISO 12215-3:2002.</p>
